



# Safe Table Meetings

## Overview:

KIPSQ will conduct a Safe Table topic every month, excluding December, in three different locations throughout the state. Participants will:

- Generate candid discussion and share organizational experiences on patient safety and quality issues
- Exchange information about best practices relative to patient safety
- Encourage coordinated/collaborative efforts and new partnerships
- Network and communicate

## Who Should Attend:

Hospital chief medical officers, chief nursing officers, patient safety professionals, patient safety officers, risk managers and quality team members are encouraged to attend. Hospitals are also asked to select 1-2 front-line staff members to attend. Safe Tables are in-person meetings – no participation is permitted by conference call.

## Participation:

Attendees are encouraged to come prepared for open discussion with colleagues by bringing an example of an adverse event (omitting patient and clinician identifiable information) related to the topic of discussion. All information shared in the Safe Table will remain confidential inside and outside of the meeting. All participants are required to sign a privacy agreement upon arrival at the meeting.
